Installation of Tilt-Tie

Installation and Use Instructions

The following instructions should be carefully read and followed for safe and satisfactory use of your **Tilt-Tie**.

- The **Tilt-Tie** is simple and easy to install. Installs in 10-50 minutes. Think out carefully where you are intending to mount the **Tilt-Tie** especially when more then one unit is being mounted.
- Each **Tilt-Tie** should be mounted at least 14 feet apart to avoid the livestock or horses from tangling. <u>Units CANNOT be mounted closer then 36" from the rear corner of trailer. Flex post will bend if mounted any closer to a corner. This will void the warranty!</u>
- Additional Receiver Base Units are available for multiple **Tilt-Tie** locations.
- A height of about 7 feet is recommended but this may vary depending on the height of the animal being tethered and height available for mounting on a trailer. The **Tilt-Tie** should be mounted high enough to allow for free movement without the unit coming in contact with the animal's head during normal movement.
- Your tether rope should hang to between 2 and 3 inches from the ground. (adjustable tether rope is included) It is important that the tether not be long enough that the animal can step over it.
- Never use the **Tilt-Tie** without the swivel style quick release (supplied) being used.
- The **Tilt-Tie** Receiver Base Unit may be mounted to the outside of a trailer using two 7/16" X 3-1/2" Grade 5 bolts. The 7/16" nuts are self-locking (supplied). Other length bolts may be needed depending on the construction and thickness of the mounting area you have selected. The mount spot selected must have the structural integrity such as a trailer frame post to support the **Tilt-Tie** when in use. Sheet metal or Aluminum Skin used in the trailer industry will not give adequate support! The Receiver Base Unit may also be lag bolted to a wooden post or pole. The Receiver Base Unit must be mounted vertically with the tie post horizontal. The flat washers are used on the inside to give the mounting bolts the needed rigidity.

Caution: Bolts must be installed from the outside with the nuts and washers on the inside. It may be necessary to trim the bolt on the inside if it protrudes on the inside to avoid injury to your animals.

Warning: Animals should not be left unattended while using this product. This product should not be used to restrain animals of unpredictable temperament. Assessment of the temperament is the sole responsibility of the owner or user.

The **Stainless Steel with Brushed Finish Base & Polished Finished** tie post **Tilt-Tie** makes real sense. No paint or maintenance!

The **Tilt-Tie** simply swings back along the trailer for transporting. Or can be removed with out tools or winches.


